**WELCOME:** SCSA (boys) and GSE (girls) have been providing community soccer in the Southeast Cincinnati area for over 45 years. Our programs provide kids the opportunity to have fun, exercise and learn teamwork playing recreational soccer. Last fall we had around 130 teams in all ages. There are no try-outs, and you don't need experience to play. Players are assigned to teams based on age and neighborhood areas. Younger players learn a simplified game on a smaller sized field.

**REGISTER BY MAIL OR ONLINE:** Players who wish to participate in the spring season must register and pay the league registration fee using either the online Registration System (pay by credit card) or by mailing this application (see reverse side for details) with your check. The League Fee covers referee and game costs. The coach is responsible to collect other potential costs for the team like a goalie shirts, or uniforms.

**DEVELOPMENT ACADEMY:** Girls and boys born in 2011, 2012, and 2013: your registration fee includes enrollment in our Development Academy. Operated by our partner Cincinnati United Soccer Club (the largest and most successful competitive soccer club in the area), the Academy features age-appropriate training through individual skills, techniques and fun games led by their professional coaches on six consecutive Friday nights during both the spring and fall seasons.

**LATE REGISTRATION POLICY:** Late registrations will be accepted if possible. Players registered late may be placed on any team.

**IF MY SON/DAUGHTER DOESN'T PLAY, CAN I HAVE A REFUND?** Boys policy: refunds before the due date are automatic. After the due date, refunds only for players who get injured, move or can't be placed on a team.

**BORN IN 1999 - 2002:** Players born in this age group may play a co-ed pick-up style game, depending on enrollment.
